



# PLAY LOFT BIRTHDAY PARTY RENTAL RULES & REGULATIONS

Play Loft is an unsupervised under surveillance birthday party facility. We are only renting the space to parents/guardians, caregivers and to their guest for the duration of their time. They are solely responsible for the safety and conduct of themselves and their children while in our facility.

Although every consideration has been given to the safety of the children and for the adult's in our space, we are not responsible for any injury that may occur resulting from safe or unsafe play or any use of any equipment. This equipment is not limited to only those used in the play area, but any area at Play Loft, sitting or standing; the responsibility of any injury incurred lies solely on those procuring the space.

Play Loft is entirely free from any liability, including monetary responsibility for such injuries incurred, regardless of whether injuries are caused by negligence or not.

By signing this document we are ensuring our compliance with the listed requirements by Play Loft -

- Please inform the guests that sick parents or children will not be allowed within the premises
- Socks only in the playground.
- Indoor shoes are worn always in the other part of our building.
- **NO** eating or drinking in the playground.
- All food and drink must stay in the designated party area.
- **NO** gum chewing while playing in the playground.
- **NO** alcohol is permitted when renting the space,
- Children must go down the slides one at a time, feet first
- This is a nut free environment hence all food brought in the space should be void of nuts.
- **NO** use of the kitchen during the duration of the party (NO access to microwave, stove tops, sinks or any of the kitchen supplies)
- Book, games and any display items are Play Loft property and any loss or damage incurred during the party will need to compensate by the hosts renting the space.

Please also note that while renting our space you are responsible for any damages caused by your guest during the time of your party.

# PLAY LOFT LIABILITY WAIVER

**ASSUMPTION OF RISK:** I agree that I and/or my child/ward are voluntarily hosting a party at Play Loft and participating in the activities offered including, but not limited to, the use of the equipment, facilities and the premises. I am assuming on behalf of myself and/or child/ward, all risk of personal injury, death, or liability to myself and/or child/ward that may result from participation, or any damage, loss or theft of any personal property which me and/or child/ward may incur. Further, it is my responsibility to inform parent/guardians of these risks in attendance of the party.

**RELEASE OF LIABILITY:** I understand that myself and/or child/ward will be engaging in recreational activities while using Play Loft facility and it is my voluntary and informed decision to release any future lawsuits or claims that they may have against the releases. Therefore, I agree on behalf of myself and my child/ward and our personal representative, successors, heirs, and assigns to hold Play Loft and its affiliates, operator, employees, as well as the property owner and tenants of the property and the installers of the equipment comprising Play Loft harmless from any and all claims or causes of action arising out of me and my child/wards participation at any event hosted at Play Loft.

This Waiver and Release of Liability includes, without limitation, injuries, or accidents, which may occur as a result of the:

- (a) Use or misuse of the facility in any way by anyone,
- (b) Use of any equipment that malfunctions or breaks,
- (c) Improper maintenance of the facility, or any equipment,
- (d) Slipping, tripping and /or falling while in the facility or on the surrounding premises.

**I ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS WAIVER AND RELEASE AND FULLY UNDERSTAND THAT IT IS A RELEASE OF ALL LIABILITY AND A WAIVER OF ANY RIGHT THAT I MAY HAVE ON BEHALF OF MYSELF AND OR MY CHILD/WARD TO BRING A LEGAL ACTION OR ASSERT A CLAIM FOR INJURY OR LOSS OF ANY KIND AGAINST PLAY LOFT. SHOULD ANY CLAIM BE MADE, I UNDERSTAND AND AGREE THAT I WILL BE RESPONSIBLE FOR ALL ATTORNEYS FEES AND DEFENSE COSTS INCURRED BY PLAY LOFT IN CONNECTION WITH OR IN THE DEFENSE OF THAT CLAIM.**
